Specific Qualifications:

Type 1.1

1) Applicants must comply with the regulations of Maejo University on graduate studies and the annual announcement regarding admissions for each academic year.

2) Applicants must hold a master's degree or its equivalent in Economics, Applied Economics, Development Studies, Administration, Agricultural Science, Political Science, Business Administration, Management, Social Sciences, or other related fields, or their equivalent from an institution recognized by the Office of the Higher Education Commission (OHEC) or the Office of the Civil Service Commission (OCSC), with a cumulative grade point average (GPA) of not less than 3.00. In cases where applicants have graduated in a related field not explicitly listed above, and are accepted through the admission process, they may be required to undertake additional coursework as recommended by the advisory committee and approved by the curriculum supervisor. Applicants without a background in Economics may be required to take prerequisite courses as advised by the program.

3) Applicants must have completed at least one degree, either bachelor's or master's, in Economics.

4) Applicants must have experience in research work or relevant professional experience.

5) International students seeking admission must obtain approval from the program advisor.

Type 2.1

1) Applicants must comply with the Maejo University Regulations on Graduate Studies and the university's annual announcement regarding admissions for each academic year.

2) Applicants must have completed a master's degree or its equivalent in Economics, Applied Economics, Development, Administration, Agricultural Science, Political Science, Business Administration, Management, Social Sciences, or other related fields, or its equivalent from an institution recognized by the Office of the Higher Education Commission (OHEC) or the Office of the Civil Service Commission (OCSC), with a cumulative GPA of not less than 3.00.

If the applicant has graduated in a related field not explicitly stated, upon passing the admissions examination, they may be required to undertake additional coursework as recommended by the advisory committee and approved by the program supervisor. Applicants without a background in Economics may also be required to take prerequisite courses as advised by the program faculty.

International students seeking admission must receive approval from the program supervisor.

Required Application Documents:

- A digital file of a straight-face photograph, size 1 inch (300 x 400 pixels), without a hat or dark glasses, taken within the last 6 months; graduation gown photos are not permitted (to be uploaded to the application system).
- A recommendation letter, in the format provided by the Admissions and Public Relations Division, duly filled and signed by a supervisor, a former instructor, or an individual who knows the applicant well (excluding family members).
- A copy of the passport (only the first page with personal information).
- A copy of the Master's Degree Academic Transcript
- A copy of the undergraduate transcript.
- A certificate of student status for those in the final semester of their Master's Degree Program
- A copy of the document showing name/surname change, or marriage certificate (in case the name/surname does not match other application documents).
- A Concept Paper in accordance with the attached template
